Question 2**DISCRIMINATION AND HUMAN RIGHTS VIOLATIONS IN THE TERTIARY SECTOR AND THE WORKPLACE.**

Read the extract below and answer the questions that follow.

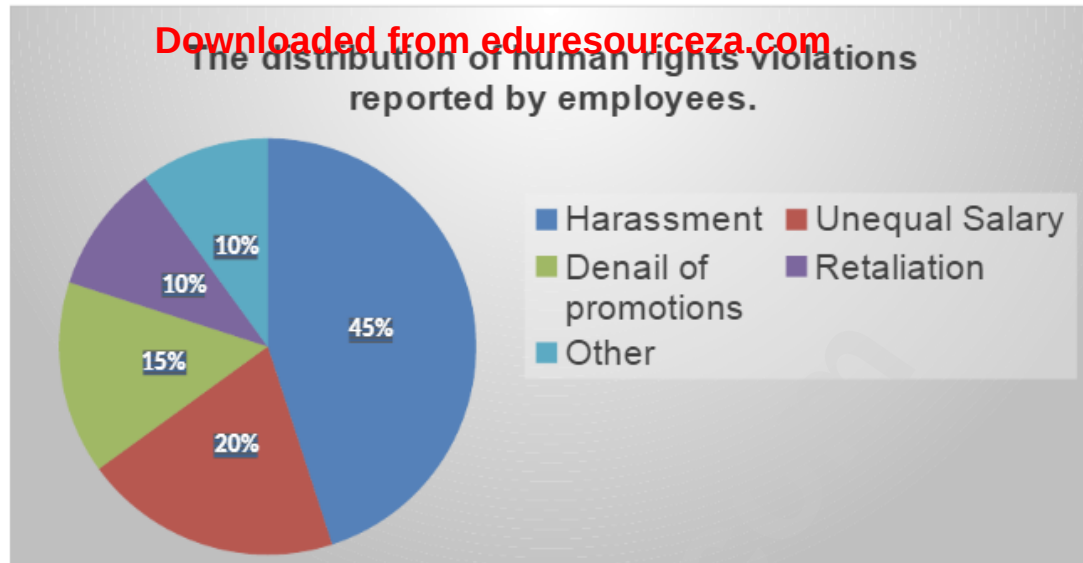
Discrimination still plagues communities in South Africa

The data indicates a concerning ¹prevalence of discrimination in the workplace, with harassment being the most reported at 45%. Harassment emerged as the predominant act of human rights violation. The pie chart below reveals a concerning upward ²trend in reported discrimination and highlights the urgency for proactive measures to address these issues in the tertiary sector.

However, the challenges of human rights violation are not experienced, exclusively, in one environment. Society, across cultures, religions, sexual orientation, language etc. experience one form or the other of discrimination and contributes to high levels of intolerance in communities. For example, incidents of xenophobia manifest themselves in various ways and people react to it in different ways. Some have become immune to it that it has become normalized; while others may develop various forms of psychological, emotional, and social challenges. Both males and females experience discrimination, xenophobia, prejudice etc. in various ways and different contexts. The unfortunate consequence is that it is not tolerable and creates unnecessary frictions in relationships, communities, and society at large. Therefore, it permeates all sectors of the community, including schools.

School going youth are at the receiving end of the scourge of gender-based violence, discrimination, xenophobia etc. This is mainly because they are raised in societies where these social ills have become normalized. They may then view it as a normal way of relating to each other. They do not realise the devastating effects those actions may have on the victims. Some victims may even decide not to report such cases and that fuels such incidents, and the perpetrators may not even realize how others feel about their acts. The statistics below demonstrate how the problem has grown and how certain sectors of societies grapple with it.

The Electoral Commission (IEC) has again partnered with social media giants Google, Meta and TikTok, and non-profit organisation Media Monitoring Africa (MMA) to curb disinformation ahead of South Africa's 2024 National and Provincial Elections on the 29 May 2024.

The above parties signed a Framework of Co-operation to not only work together to combat disinformation and other digital harms, but also to safeguard the integrity of information and preserve the basic principles of our democratic elections.

An important reason for this was that the rapidly increasing use of digital media in recent years has also resulted in an upswing of digital disinformation, particularly on social media platforms and even during electoral processes.

Social media platforms will help to identify, investigate and prioritise referrals or complaints received from the Commission during the election period and thereafter take action. The platforms, in terms of their policies may action the following: removal of the content, the publication of an advisory warning and/or the delisting of the post.
